





## Family First Prevention Services Act Overview

- Prevention Services
  - 3 Areas: mental health, substance use and in-home parenting skills
- Provides support for Kinship Caregivers
- Ensuring appropriate placement (prioritizing family and increased requirements/oversight on congregate placement)
- Improves services for older youth



## **Family First Transition Act**

- To support the timely implementation of the Family First Act, Congress passed and the President signed into law the Family First Transition Act of 2019 (H.R. 4980/S.2777)
- The Transition Act authorized \$500 million in FY2020 to all states and to tribal nations for transition grants for activities related to implementation of FFPSA with no match requirement.
- The Transition Act provides one-time, flexible funding for states and tribes
  to help implement Family First, as well as short-term funding guarantees
  for states with expiring Title IV-E waivers. This will allow states to move
  forward with Family First without a financial shortfall during their
  transition.
  - 22 states, the District of Columbia, and the Port Gamble, S'Klallam Tribe are eligible for these additional funds.

## **Current Status of Family First Implementation:**

#### Where is your state in the implementation process?

#### Submitted

- States: 9 (Alaska, Colorado, Hawaii, Iowa, Illinois, Maine, Ohio, Oregon, Virginia)
- Tribes: 2 (Aleut Community of St. Paul Island, AK; Eastern Band of Cherokee Indians, NC)

#### Approved

 States: 10 (Arkansas, DC, Kansas, Kentucky, Maryland, North Dakota, Utah, Washington, West Virginia, Nebraska)

The majority of states do not have approved Family First plans three years after passage of the Family First Act.

The BIG ideas:

- Provides states and tribes the new option to use uncapped federal funding (Title IV-E) for prevention services for children at imminent risk of foster care entry and their families also applies to parenting and pregnant youth in care.
- Evidence-based prevention services such as:
  - substance abuse
  - mental health
  - skill-based parenting supports (such as parenting skills training, parent education, individual and family counseling)

#### The BIG ideas:

- Children and youth do better when they can live with relatives (rather than strangers or in institutions).
- States can receive federal reimbursement for up to 50% of their expenditures to provide kinship navigator programs that meet certain evidence-based requirements.
- Seeks to improve licensing standards for foster family homes including kinship placements.

The BIG ideas:

- For youth placed in a setting other than family-like, federal Title IV-E funds will be limited to settings that meet the following requirements as Qualified Residential Treatment Settings
  - Trauma-informed treatment model
  - Nursing / licensed clinical staff onsite
  - Engage child's family in treatment plan
  - Discharge planning and family-based aftercare (at least 6 months)

#### The BIG ideas:

- Shifts language to emphasize **transition to** adulthood rather than **independence**.
- Allows services and education support for youth who have experienced foster care age 14+ (Currently 16+)
- Eligible for Education and Training Vouchers (ETV)
  until age 26 (Currently age 23). Use ETVs for up to
  5 years non-consecutively.
- Adds achieving connections to caring adults and positive youth development to the service array.





## New Opportunities for Family First



Temporarily increases the federal reimbursement rate up from 50% to 100% for the Title IV-E Prevention Program, created under the Family First Prevention Services Act of 2018, for the duration of the COVID19 public health emergency period (April 1, 2020 through September 30, 2021).

## Consolidated Appropriations Act

- Temporarily increases the federal reimbursement rate up from 50% to 100% for the Title IV-E Prevention Program, created under the Family First Prevention Services Act of 2018
- for the duration of the COVID19 public health emergency period (April 1, 2020 through September 30, 2021).



## Consolidated Appropriations Act

**Prevention Services**

- Provides 100% reimbursement for kinship navigator program services provided from April 1, 2020 through September 30, 2021.
- Waives the requirement that for kinship navigator services to be reimbursed they meet the evidence-based standard required in Family First.



## Consolidated Appropriations Act

**Prevention Services** 

Kinship

Older Youth

- Provides an additional \$400 million for the John H. Chafee Foster Care Independence Program for FY2021, with no state match. Also Increases the age of eligibility of services to age 27 Removes the 30 percent cap on room and board.
- Provides an additional \$50 million for Education and Training Vouchers (ETV, with no state match. And Increases the maximum ETV from \$5,000 to \$12,000 per year through FY2022


